ANNUAL TOWN MEETING – 3rd Tuesday

Tuesday, April 19th, 7pm – Annual Meeting, followed by Regular Town Board Meeting. Location: **Timberland Lutheran Church**. Due to 2012 election law changes, the annual town meeting is changed to the 3rd Tuesday in April to coincide with town officer terms now expiring on the 3rd Tuesday in April. An ordinance was enacted in May of 2012 to extend current town officer terms one week to correspond with new laws.

TOWN CLEAN-UP

Saturday, May 21st, 8am-noon. The dumpsters will be located at Greg Odden's farm, just west of Timberland Church on Odden Road. Signs will be posted. No fee items include: Scrap metal, appliances, computer towers, cell phones, cable boxes, laptop computers, lead acid batteries, electronic boards, RECHARGEABLE BATTERIES. Per item electronic fees are: Small electronics (DVD players, VCR's, printers, etc) **\$1**, TV's and computer monitors- **\$15**. Other items requiring a fee will be determined at cleanup. Loads for dumpster will be **\$20** for small loads, **\$30** for medium loads, and **\$40** for large loads. Checks are preferred, but cash will be accepted. Please bring exact change if possible.
